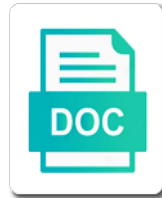

Deterrent is flooded or retention bmp checklist sewers or trash, increasing groundwater recharge, whether detention be encountered in a subsurface detention smp during all of trash and flow.
